

External Trade of Macao in the Third Quarter of 2023

Overview


External merchandise trade of Macao totalled MOP37.31 billion in the third quarter of 2023, up by 18.6% from the MOP31.45 billion in the same quarter of 2022. Merchandise imports rose by 19.9% to MOP34.16 billion and merchandise exports went up by 6.4% to MOP3.15 billion. The exports-imports ratio decreased by 1.2 percentage points year-on-year to 9.2%. Merchandise trade deficit increased from MOP25.53 billion in the third quarter of 2022 to MOP31.01 billion.

Total Exports

Total merchandise exports grew by 6.4% year-on-year in the third quarter of 2023, with domestic exports dropping by 7.2% while re-exports rising by 9.0%.

Analysed by destination, merchandise exports to the EU (MOP48.8 million), Viet Nam (MOP25.0 million) and mainland China (MOP290.7 million) expanded by 37.4%, 16.1% and 4.0% respectively. On the other hand, exports to Singapore (MOP22.8 million), India (MOP19.8 million), the USA (MOP152.1 million) and Hong Kong (MOP2.13 billion) slipped by 46.4%, 13.2%, 9.7% and 5.8% respectively.

Exports of diamond & diamond jewellery, the leading export commodity, hiked by 71.9% to MOP477.3 million, accounting for 15.2% of the total exports. Exports of electronic components, machines & apparatus, parts & accessories thereof and tobacco & wine swelled by 5.8%, 2.5% and 2.2% respectively, whereas exports of copper & articles thereof, watches and garment & textile products shrank by 42.8%, 25.9% and 23.7%. Meanwhile, exports of other products rose by 21.8%.



Domestic Exports

Domestic exports amounted to MOP439.4 million (13.9% of total exports), down by 7.2% year-on-year but up by 4.8% quarter-on-quarter. The USA was the largest market of Macao's domestic exports (33.2% of total domestic exports), with the corresponding value of exports dropping by 11.6% year-on-year. Value of exports to Viet Nam, the EU and Canada rose by 59.0%, 40.4% and 17.4% respectively, while that to Singapore, Hong Kong, mainland China and India declined by 63.8%, 15.8%, 15.3% and 11.6% respectively. Analysed by type of commodity, exports of garments (30.4% of total domestic exports) slid by 15.1%, of which exports to Hong Kong (1.0% of total domestic exports of garments) and the USA (96.9%) shrank by 81.8% and 9.2% respectively. Exports of tobacco (11.1% of domestic exports) went up by 52.8%; meanwhile, exports of copper & articles thereof (13.9%) dipped by 42.7% while those of other products (44.6%) rose by 10.4%.

Domestic exports to mainland China fell by 15.3% to MOP68.6 million (15.6% of domestic exports), of which tariff-free merchandise exports under the Mainland and Macao Closer Economic Partnership Arrangement (CEPA) decreased by 37.7% to MOP21.8 million, consisting mainly of copper-clad boards (28.3% of total). The amount of tariff saved totalled MOP1.8 million.

Re-exports


Total value of re-exports increased by 9.0% to MOP2.71 billion (86.1% of total exports) in the third quarter of 2023. Hong Kong was the largest market of Macao's re-exports (74.5% of re-exports), followed by mainland China (8.2%). Value of re-exports to mainland China rose by

11.9%, while that to Viet Nam and Hong Kong dipped by 33.3% and 5.1% respectively. In terms of types of commodities, re-exports of raw materials & semi-manufactures (5.6% of re-exports) swelled by 65.4% while those of consumer goods (60.3%) reduced by 8.8%; on the other hand, re-exports of other products (34.1%) expanded by 53.0%.

Imports

Total value of merchandise imports rose by 19.9% year-on-year to MOP34.16 billion in the third quarter of 2023. Mainland China was the main supplier of goods imported to Macao (30.5% of total imports), and the value of imports rose by 15.1% to MOP10.42 billion. As regards other places of origin, value of imports from Hong Kong (6.1% of imports), Japan (6.2%), United Kingdom (2.0%), the EU (29.5%), Switzerland (6.8%) and the USA (5.9%) showed respective growth of 62.1%, 33.3%, 32.7%, 19.5%, 14.5% and 0.1%.

Regarding the types of commodities, imports of fuels & lubricants (6.0% of total imports), consumer goods (74.2%), capital goods (12.3%) and raw materials & semi-manufactures (7.5%) climbed by 22.7%, 21.8%, 16.1% and 7.5% respectively. Imports of consumer goods showed a year-on-year rise; imports of gold jewellery (11.1% of total imports), motor cars & motorcycles (1.5%), clothing & footwear (9.4%), handbags & wallets (7.6%), food & beverages (16.1%) and watches (6.3%) expanded by 95.8%, 35.6%, 29.7%, 29.5%, 20.9% and 5.5% respectively, whereas imports of beauty, cosmetic/skin-care products (8.1%) dropped by 18.9%. Meanwhile, imports of other consumer goods (14.1%) rose by 19.7%.
