

External Trade of Macao in the Second Quarter of 2023

Overview


External merchandise trade of Macao totalled MOP39.24 billion in the second quarter of 2023, up by 0.9% from the MOP38.88 billion in the same quarter of 2022. Merchandise imports rose by 1.2% to MOP36.03 billion while merchandise exports went down by 2.6% to MOP3.21 billion. The exports-imports ratio decreased by 0.4 percentage points year-on-year to 8.9%. Merchandise trade deficit increased from MOP32.29 billion in the second quarter of 2022 to MOP32.81 billion.

Total Exports

Total merchandise exports fell by 2.6% year-on-year in the second quarter of 2023, with domestic exports dropping by 23.3% while re-exports rising by 1.5%.

Analysed by destination, merchandise exports to Viet Nam (MOP34.4 million), Singapore (MOP53.0 million) and India (MOP21.4 million) expanded by 27.2%, 10.2% and 0.4% respectively. On the other hand, exports to Japan (MOP1.8 million), mainland China (MOP211.1 million), the USA (MOP136.7 million), the EU (MOP42.9 million) and Hong Kong (MOP2.36 billion) slipped by 88.0%, 48.1%, 24.9%, 21.6% and 2.5% respectively.

Exports of machines & apparatus, parts & accessories thereof, the leading export commodity, increased by 28.2% to MOP531.8 million, accounting for 16.6% of the total exports. Exports of tobacco & wine swelled by 9.0%, whereas exports of electronic components, diamond & diamond jewellery, copper & articles thereof, garment & textile products and watches shrank by 47.6%, 40.5%, 40.0%, 29.5% and 11.8% respectively. By contrast, exports of other products rose by 22.9%.



Domestic Exports

Domestic exports amounted to MOP419.2 million (13.1% of total exports), down by 23.3% year-on-year but up by 35.4% quarter-to-quarter. The USA was the largest market of Macao's domestic exports (31.6% of total domestic exports), with the corresponding value of exports dropping by 23.8% year-on-year. Value of exports to Canada, Viet Nam and India rose by 27.8%, 12.5% and 0.1% respectively, while that to Singapore, mainland China, the EU and Hong Kong declined by 83.5%, 31.7%, 25.2% and 10.9% respectively. Analysed by type of commodity, exports of garments (31.6% of total domestic exports) slid by 32.4%, of which exports to Hong Kong (1.9% of total domestic exports of garments) and the USA (87.4%) shrank by 69.9% and 23.7% respectively. Exports of tobacco (9.4% of domestic exports) went up by 121.7%; meanwhile, exports of copper & articles thereof (17.2%) and other products (41.8%) dipped by 40.3% and 17.5% respectively.

Domestic exports to mainland China fell by 31.7% to MOP59.7 million (14.2% of domestic exports), of which tariff-free merchandise exports under the Mainland and Macao Closer Economic Partnership Arrangement (CEPA) decreased by 48.2% to MOP12.4 million, consisting mainly of copper-clad boards (65.5% of total). The amount of tariff saved totalled MOP619 thousand.

Re-exports


Total value of re-exports increased by 1.5% to MOP2.79 billion (86.9% of total exports) in the second quarter of 2023. Hong Kong was the largest market of Macao's re-exports (80.4% of re-exports), followed by mainland China (5.4%). Value of re-exports to Viet Nam jumped by

337.6%, while that to mainland China and Hong Kong declined by 52.6% and 2.0% respectively. In terms of types of commodities, re-exports of consumer goods (53.7% of re-exports) and raw materials & semi-manufactures (3.3%) reduced by 24.2% and 23.6% respectively; on the other hand, re-exports of other products (43.0%) surged by 83.8%.

Imports

Total value of merchandise imports rose by 1.2% year-on-year to MOP36.03 billion in the second quarter of 2023. The EU was the main supplier of goods imported to Macao (31.9% of total imports), and the value of imports dropped by 0.9% to MOP11.48 billion. As regards other places of origin, value of imports from Hong Kong (4.6% of imports) and Switzerland (7.3%) rose by 61.3% and 4.9% respectively. By contrast, value of imports from the USA (6.2%), Japan (6.3%), United Kingdom (1.7%) and mainland China (26.3%) diminished by 19.5%, 13.8%, 13.3% and 11.6% respectively.

Regarding the types of commodities, imports of fuels & lubricants (5.0% of total imports) and consumer goods (77.4%) climbed by 9.7% and 7.5% respectively, whereas those of capital goods (10.1%) and raw materials & semi-manufactures (7.6%) decreased by 30.2% and 3.5% respectively. Imports of consumer goods showed a year-on-year rise; imports of gold jewellery (9.9% of total imports), motor cars & motorcycles (1.3%), food & beverages (18.5%), handbags & wallets (8.2%), clothing & footwear (8.5%) and watches (6.8%) rose by 61.1%, 51.7%, 32.8%, 8.7%, 2.6% and 0.6% respectively, whereas imports of beauty, cosmetic/skin-care products (9.8%) dropped by 33.2%. Meanwhile, imports of other consumer goods (14.3%) rose by 4.2%.
